The Richmond County District Attorney (RCDA) is seeking one (1) full time Assistant District Attorney to serve as the Executive Assistant District Attorney for Investigations on matters involving investigations, narcotics enforcement, crime strategy and matters involving allegations of crimes by public servants, including police officers. Other responsibilities include but are not limited to monitoring and reporting to the District Attorney all allegations of police misconduct to include matters before the Civilian Complaint Review Board (CCRB). The prospective candidate will act as the office liaison with the police department to include, but not limited to, the Internal Affairs Bureau. Duties will also include overseeing critical incidents such as police involved shootings.
