Staten Island's Hate Crimes Task Force

LED BY DISTRICT ATTORNEY MICHAEL E. McMAHON & SCOTT MAURER, CEO OF COJO OF STATEN ISLAND, THE HATE CRIMES TASK FORCE WAS CONVENED AFTER THE UNSPEAKABLE TRAGEDY THAT OCCURRED AT THE TREE OF LIFE SYNAGOGUE IN PITTSBURGH IN OCTOBER 2018, IN WHICH ELEVEN INDIVIDUALS WERE KILLED IN AN ANTISEMITIC ATTACK. THE STATEN ISLAND HATE CRIMES TASK FORCE WORKS TOGETHER WITH ALL OUR COMMUNITIES TO ADDRESS INTOLERANCE AND BIGOTRY, AS WELL AS INFORM OUR NEIGHBORS THAT OUR DIFFERENCES MAKE US STRONGER AND HATE HAS NO PLACE IN OUR BOROUGH.



THE HATE CRIMES TASK FORCE IS COMPRISED OF MEMBERS FROM A MULTITUDE OF DIVERSE BACKGROUNDS, SERVING AS AMBASSADORS WITHIN THEIR OWN COMMUNITIES TO PROMOTE GREATER UNDERSTANDING AND TOLERANCE OF ALL STATEN ISLANDERS. IN OUR EFFORT TO COMBAT HATE ACROSS THE BOROUGH, THE TASK FORCE WORKS TOGETHER TO EDUCATE AND EMPOWER THROUGH VARIOUS COMMUNITY INITIATIVES.



How to Recognize & Report a Hate Crime

ANY CRIME BECOMES A HATE CRIME WHEN IT IS MOTIVATED BY BIAS AGAINST AN INDIVIDUAL'S PERCEIVED RACE, COLOR, RELIGION, NATIONAL ORIGIN, SEXUAL ORIENTATION, GENDER, GENDER IDENTITY OR DISABILITY.



A PERSON REPORTS A HATE CRIME IN THE SAME MANNER AS THEY WOULD REPORT ANY OTHER CRIME. IF IT IS A CRIME IN PROGRESS, CALL 911. IF IT IS A CRIME THAT DOES NOT ENDANGER ANYONE, OR A CRIME THAT OCCURRED IN THE PAST, CALL YOUR LOCAL PRECINCT. THE RESPONDING OFFICERS WILL PROVIDE WHATEVER IMMEDIATE ASSISTANCE IS NEEDED, AND BEGIN THE REPORTING PROCESS. IF THE SITUATION IS DEEMED TO BE A POSSIBLE BIAS-MOTIVATED INCIDENT, THE NYPD HATE CRIMES TASK FORCE WILL BE NOTIFIED.
