**THE ROLE**

The Richmond County District Attorney (RCDA) is seeking a law enforcement professional for the position of the Deputy Chief Detective Investigator. The responsibilities of the position include, but are not limited to the following:

- Supervise investigations on a wide variety of matters, including but not limited to: cold case homicides; organized crime; narcotics; identity theft; financial crimes; violent crime; special victim cases; domestic violence; welfare fraud; child abuse; gangs; hate crimes; firearms.
- Oversee in transporting witnesses for grand jury/court appearances
- Supervise background checks and interviews for prospective Detective Investigators.
- Supervise surveillances and assist prosecutors with trial preparation.
- Interview witnesses and arrange for witness protection at the direction of the Chief Investigator.
- Other duties as assigned

**MINIMUM REQUIREMENTS**

1. An Associate degree or 60 credits from an accredited college, with specialization in police science, criminal justice or law enforcement and either one (1) year of full time satisfactory experience as a police officer or deputy sheriff of an authorized police department or sheriff's office or one (1) year of full time satisfactory experience performing criminal investigations in which field work comprised a substantial part of the duties; or
2. A four year high school diploma or its educational equivalent and either three (3) years of full time satisfactory experience as a police officer or duty sheriff or three (3) year of full time paid experience performing criminal investigations in which field work comprised a substantial part of the duties; or
3. A combination of education and/or experience which is equivalent to the requirements in "1" and "2" above. However, all candidates must a high school diploma or its equivalent.

**Driver License Requirement:** You must have a motor vehicle driver license valid in the State of New York at the time of appointment. This license must be maintained for the duration of your employment.

**PREFERRED SKILLS**

- Three or more years of full-time, paid employment as defined in CPL §1.20, within the State of New York.
- Accredited police academy training.
- Certified in firearms proficiency.
- Three or more years of investigative experience.
- Five or more years of supervisory experience in law enforcement and investigations.
- Strong technical computer skills using a variety of applications for law enforcement use, including law enforcement photography and videotaping skills regarding, e.g., crime scenes, lineups, interrogations, victim injuries.
- Knowledge of systems used for surveillance and search warrants.
- Experience in facilitating and conducting training and qualification courses for Investigators.
- Proficient in Microsoft Suite.
- Oversee administrative duties such as, time and leave for a large unit.
- Experience in supervising the maintenance of surveillance equipment and inventory items.
